GETTING STARTED

Avis Car Sales wants you to feel comfortable about giving us access to your personal information. Use this Privacy Notice to find out what happens to your personal information when you interact with Avis Car Sales and what choices you have.

This Privacy Notice covers the personal information that Avis Car Sales collects, uses and discloses through your use of our website.

We collect personal information when you give it to us, such as by telephone, fax, postal mail, email, in person, or through your use of Avis Car Sales’ website.

Sometimes, we may combine your personal information with other information we received from other sources so we can provide you a more customized and hassle-free experience. We may obtain personal information about you from a third party. Additionally, our affiliates and third parties may provide us with information about you.

We may also automatically collect information about your devices when you use our website. To learn about our online data collection, go to the [Online Data](#) section.

Any disputes regarding how we handle your personal information will be governed by the terms of your test drive, rental, vehicle purchase or the terms of use of our website, unless otherwise required by applicable law.

This may include mandatory arbitration of disputes.

TEST DRIVES

When you book a test-drive appointment, we collect your name, location, contact information, and vehicle type preference. We will provide this information to an Avis or Budget location who will arrange for your test drive. Please see the [Avis Budget Group Privacy Notice](#) for information on how your personal information will be collected, used and disclosed in connection with your test drive.

ONLINE DATA

When you visit and use our website or download our mobile application, Avis Car Sales automatically collects information. This section tells you more about what information we collect and why we collect it.

IP Addresses & other information collected automatically: We may collect your IP address when you visit our websites to help us diagnose problems with our systems, for system administration, to report aggregated information to our business partners, and to audit the use of our website. In select circumstances, we may use IP addresses to help us identify you when we feel it is necessary to enforce compliance with our Website Terms of Use or to protect our service, site, users or others. We may also collect your browser type, Internet Service Provider (ISP), referring/exit pages, the files viewed on our site (e.g., HTML pages, graphics, etc.), operating system, date/time stamp, and/ or clickstream data to analyze trends in the aggregate and administer the site.

Cookies & other similar technologies: We use cookies, scripts, pixel tags, etags, web beacons and other similar technologies to help us recognize you, remember your previous preferences, and vehicle interests, etc., so you don't have to tell us over and over again! This helps us make the website more convenient and efficient. We also use these technologies to track website usage trends and patterns, personalize features, and tailor advertisements to you and provide you with a personalized marketing experience. We share website usage information about visitors with selected third parties for the purpose of targeting our Internet advertisements on our websites and other websites that display our advertisements. ONLINE ADVERTISING

SOCIAL MEDIA

Social Sharing

Avis Car Sales lets you share some Avis Car Sales online content on social media websites through hosted sharing links and icons. ANALYTICS

We use analytic software, such as Google Analytics and others, to help us to better understand the functionality of our software on our websites and Apps on your device. This software may record information such as how often you use our App, which features you use or don't use in the App,

aggregated usage, performance data, and where the App was downloaded from. This information isn't connected to you.

If you do opt out of receiving promotional and marketing messages, we can still contact you regarding our business relationship with you, such as appointment status and updates, survey requests after you test drive with us, or respond to your inquiries or complaints, and similar communications.

SAFEGUARDS

The security of your personal information is important to us. We take reasonable steps to make sure your information is protected from unauthorized use, access, disclosure, alteration, destruction or loss. For more sensitive personal information, we use firewalls and Transport Layer Security (TLS) encryption.

We do not ask for sensitive information, such as your credit card number, passcode, account number or pin number, in an e-mail, text or on a website not operated by Avis Car Sales or its affiliates. If you do receive a suspicious request, do not provide your information and report it by contacting one of our customer service representatives at utd@ifs4u.com.

STORAGE

Avis Car Sales stores your personal information in the United States. If Avis Car Sales needs to transfer your information to locations outside the United States as part of our normal business operations, the information may be subject to laws of other countries. If so, Avis Car Sales takes reasonable steps to ensure your information is treated and protected similarly as if it were in the United States. This Privacy Notice is intended to be governed by the laws of the State of New Jersey and meet the laws and requirements of the United States, which may not necessarily be consistent with the laws and regulations of the country where you live.

YOUR CALIFORNIA PRIVACY RIGHTS

Do you live in California? California Civil Code Section 1798.83 states that our California users have the right to receive specific information about how Avis Car Sales discloses personal information to others for their marketing purposes, and what choices they have. If you are a California resident under the age of 18 and you have publicly posted any information on our websites, California Business and Professions Code Section 22581 permits you to request and obtain removal of content or information you have publicly posted.
